




OCCUPATIONAL CERTIFICATE: BUS DRIVER

Purpose of the qualification

The purpose of this qualification is to prepare a learner to operate as a Bus Driver. A bus driver drives a bus or coach to transport passengers over short and/or long distances on scheduled local and or intercity services over established routes. A qualified learner will be able to drive a coach or bus to transport passengers safely and on time to scheduled and non-scheduled destinations, assist passengers with boarding and luggage, and also handle emergency situations.


Target Audience

This qualification targets people who wish to gain access to employment and entrepreneurial opportunities in passenger vehicle services. The Bus driver qualification also makes provision for people to progress within this discipline to specialisation areas including heavy vehicle driving and truck driving work.
